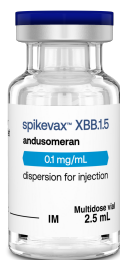

HELP PROTECT HIGH RISK PATIENTS WITH THE
UPDATED SPIKEVAX® XBB.1.5 VACCINE THIS SPRING



Guidance on an additional dose of COVID-19 vaccines in the spring of 2024 for individuals at high risk of severe illness due to COVID-19¹

Starting in the spring of 2024, NACI recommends that the following individuals who are at increased risk of severe illness from COVID-19 may receive an additional dose of XBB.1.5 COVID-19 vaccine:

- Adults 65 years of age and older
- Adult residents of long-term care homes and other congregate living settings for seniors;
- Individuals 6 months and age and older who are moderately to severely immunocompromised (due to an underlying condition or treatment).

The recommended interval is 6 months from the last COVID-19 vaccine dose. Shorter interval of at least 3 months (i.e., a minimum interval of 3 months) may be used, to support implementation (including timing of the spring campaign relative to previous and future fall campaigns).

Moderna's SPIKEVAX® XBB.1.5 COVID-19 vaccine is available in one multidose vial for administration to all eligible individuals, 6 months and up.²

According to the Canadian Immunization Guide (CIG), there is no longer a product preference between COVID-19 mRNA vaccines for individuals 12 to 29 years of age.³

SPIKEVAX® XBB.1.5 dosing considerations: Individuals ≥ 12 Years of Age: One dose of 50 mcg (0.5mL dose volume). Refer to your provincial spring guidance for high risk individuals.²
