

Registering for Fair Pharmacare

Fair PharmaCare helps B.C. families pay for eligible prescription drugs, dispensing fees and some medical supplies. To register for Fair PharmaCare, families must have Medical Services Plan (MSP) coverage. **Fair PharmaCare is income-based; the less a family earns, the more help they get.**

Who is eligible for Fair PharmaCare?

All residents of B.C. are eligible for Fair PharmaCare coverage if they have Medical Services Plan (MSP) coverage and give PharmaCare permission to check their income with CRA.

Coverage is for families, not individuals. A family can be a single person, married or common-law couple, single person with dependent children, or couple with dependent children.

- Some medical devices
- Eligible dispensing fees and some pharmacy services (such as medication reviews for persons prescribed five medications or more)

What is a deductible?
