## Conditions of Nomination:

- Awards will be presented during the BCPhA's 2023 Award Gala Event in B.C.
- This year's event gala is planned to take place at a virtual event in the fall of 2023. Recipients of an award should be prepared to make themselves available to be photographed and interviewed on video, and are expected to attend the virtual event to receive the award.
- Award recipients agree to be featured on the BCPhA website and social media channels.
- Awards in each category may not be granted every year.
- Winners for each category, other than Friend of Pharmacy, must be an active member of the BC Pharmacy Association.
- Electronic submissions must be sent through this form, or by photocopy of a physically filled form to [awards@bcpharmacy.ca](mailto:awards@bcpharmacy.ca), or through [https://bcpha.formstack.com/forms/pharmacy\\_awards](https://bcpha.formstack.com/forms/pharmacy_awards) with the nominee's name in the subject line.
- Late submissions will not be eligible for consideration for this year's awards but will be held on file for consideration for the following year.

**Nominators:** Please ensure that you complete the entire nomination form and attach supporting documentation. The nomination package will be provided to the BCPhA Awards Committee. Please ensure that it will be legible when photocopied and that you adhere to minimum and maximum requirements.

Incomplete nomination packages will not be considered. The BC Pharmacy Association would be pleased to provide advice in developing your nomination package should you require it.

**All nomination packages must be received by midnight May 31, 2023.**

# Criteria for Nomination:

## I. Excellence in Pharmacy Awards

The following awards will honour a BC Pharmacy Association member (pharmacist) who meets the criteria of one of the following awards:

- **Excellence in Patient Care Award:** This award is presented to a pharmacist who has demonstrated ongoing excellence in patient care in their professional practice.
- **Ben Gant Innovative Practice Award:** This award is presented to a pharmacist who has demonstrated significant innovation in their respective practice and/or the profession.
- **Murray Dykeman Mentorship Award:** This award recognizes a pharmacist who has demonstrated outstanding mentorship to those early in their pharmacy career.
- **Pharmacy Leadership Award:** This award recognizes a pharmacist who has demonstrated commitment to leading the profession and its people forward and has made significant contributions to the profession.
- **Collaborative Care Award:** This award recognizes a pharmacist who has worked to create strong collaboration with other health-care providers. In doing so, they have to promote the value of pharmacists and have successfully advocated for the role of pharmacists in the primary health-care team.
- **New Practitioner Award:** This award recognizes a pharmacist within their first five years of practice. They have demonstrated impact and commitment to the pharmacy profession by advancing their practice.
- **Bowl of Hygeia Award:** A pharmacist with an outstanding record of public and community service.

## II. Friend of Pharmacy Award

The BC Pharmacy Association offers the Friend of Pharmacy Award to a non-pharmacist who has worked with and promoted the value and role of pharmacists within the health-care team. This can include physicians, specialists, nurses, nurse practitioners, other health-care professionals, health authority officials, patients, decision-makers, community leaders, and other health-care organizations.

## How to Complete the Nomination:

When nominating an individual, please include all of the following:

- **Nomination Form:** please fully complete the attached form.
- **Nominator's Letter (maximum two pages):** Addressing various award criteria, please explain why this candidate should be chosen to receive an award. Please include parts of the candidate's life and profession that qualify them for a particular award. Include not only what would meet the criteria for the award, but also include interesting or unique items about them.
- **Two letters of support:** from individuals other than the nominator. These may come separately if individuals email [awards@bcpharmacy.ca](mailto:awards@bcpharmacy.ca) with the nominee's full name in the subject line and marked on each page.
- **Media clippings, if relevant (maximum two media clippings):** Ensure media clippings include a reference to the publication (name/date/page). If there are more than two clippings, please include only a list of references.
- **Additional Nominee Information, if relevant (maximum two pages):** This would include relevant volunteer experience, provincial, national or international recognition, previous awards or honours received, and membership in professional organizations or honorary societies.

Please reference candidate's name on every page of the nomination and supporting documentation.

Please fully complete the Nomination package and submit to the completed package to BCPhA by midnight May 31, 2023.

5. In what ways has the nominee advocated on behalf of pharmacists and the profession, and what has been the impact?

### Mandatory supporting evidence

All submissions must include a minimum of two pieces of evidence from the following categories listed below:

- Letter of support from a health-care peer (such as a fellow pharmacist, physician or nurse).
- Letter from a patient.
- Published documentation of achievement (such as media clippings or articles in journals).

Please combine the supporting documentation when submitting this nomination package and email to [awards@bcpharmacy.ca](mailto:awards@bcpharmacy.ca) with the nominee's name in the subject line. If other letters can not be combined with this package, other supporters may send their letters with to [awards@bcpharmacy.ca](mailto:awards@bcpharmacy.ca) with the nominee's name in the subject line. The nominee's full name must be on each page of their letter.
